### Where to Use

#### **Dilution Ratios**

**SNAP!**: Dilutes (1:32) for Both High Flow and Low Flow.

**Light soils:** Dilute (1:128) 1 oz per gallon/

30 ml per 3.8 litres of water.

Medium soils: Dilute (1:32) 4 oz per gallon/

120 ml per 3.8 litres of water.

**Heavy soils:** Dilute (1:5) 25 oz per gallon/

740 ml per 3.8 litres of water.

#### **Directions for Use**

**SNAP!** Product is designed to only be used through our SNAP! Dispenser.

Mix only with water. Apply with a mop or brush, as a pressure spray, in a dip tank or through an automatic floor scrubber.
